Why? Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also required us to tell you how we collect, Share, and protect your personal information. Please read this notice carefully to understand what we do. What? The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security Number and assets checking account information and credit history Income and employment information When you are no longer our customer, we continue to share your information as described in this notice. How? All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Charlotte County Habitat for Humanity, Inc. chooses to share; and whether you can limit this sharing.

	When collecting, storing, and retrieving personal data, such as tax returns, pay stubs, credit reports, employment verifications etc. Internal controls are maintained throughout the process to ensure security and confidentiality.

Why can't I limit all sharing?	Federal law gives you the right to limit only • sharing for affiliates' everyday business purposes - information about your creditworthiness • affiliates from using your information to market to you • sharing for non-affiliates to market to you State Laws and individual companies may give you additional rights to limitsharing.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.
	Charlotte County Habitatfor Humanity, Inc. does not share with our affiliates.
Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.
	• Charlotte County Habitat for Humanity, Inc. does not share with non-affiliates they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
	Charlotte County Habitat for Humanity, Inc. doesn't jointly market.
